### **HISTORY:**

In 1966, the International Lodge formed a Sons of Norway Foundation for the purpose of awarding scholarships, cultural grants and charitable donations. Many Canadian members donated to this worthy cause only to find that receipts issued from the United States did not qualify for tax deductions in Canada. The best solution was to form a Sons of Norway Foundation in Canada to meet the needs and benefits of Canadian members.

In 1971, the Sons of Norway Foundation in Canada was established by resolution of the District No. 7 Convention. The objectives of the Canadian Foundation would be the collection of funds by donations and bequests to be used for educational, cultural and charitable endeavours in the form of scholarships and grants. The Sons of Norway Foundation in Canada is a charitable organization established under authority of the Federal Minister of Consumer and Corporate Affairs of Canada. All contributions are eligible for deductions on tax returns for Canadian residents.

Investments are made in accredited Financial Institutions.

### DID YOU KNOW ??

The intention is to give news and share ideas on what your Foundation does for you and how you can support the Foundation.

In 2014, the Foundation gave ten \$800.00 scholarships for students wishing to attain a higher education. This scholarship is open to all students and through this Update we are encouraging all Sons of Norway members to promote your children, grandchildren, great grandchildren, relatives and friends to apply for a scholarship.

The application form is available on the *sonsofnorway.com* website click on Foundation then Canadian Foundation to download. It is very important that the applicant follow these guidelines to the letter.

- 1) Why have you chosen the scholastic field you are pursuing?
- 2) What other scholarships and bursaries have YOU applied for this year?
- 3) Give details of employment (past, present, part and/or full time).
- 4) Elaborate on your need for financial assistance, provide a budget of both income and expenses.
- 5) How have you participated in school, university and community activities?
- 6) What are your interests and hobbies?
- 7) How are you connected with the Norwegian community and what are your interests in Norway's culture?
- 8) Are you, your parents and/or grandparents currently members of Sons of Norway? If applicable please indicate all names, Lodge names and Lodge membership numbers.
